This initiative reflects our strong commitment to safeguarding the health, safety, and productivity of our workforce.

Key Benefits of Availment:

- Annual Physical Examination (APE)
- Emergency care and hospitalization
- Specialist consultations

Eliaibility:

 All active employees of Expedise PH with two (2) months tenure, are eligible for HMO coverage application. Optional dependent coverage is also available upon request and approval.

STEPS TO AVAIL HMO COVERAGE:

1. Orientation and Acknowledgment

IMS will conduct a brief orientation on the HMO plan, benefits, and procedures. Attendance is required as acknowledgment of the coverage terms.

2. Submit Authority to Deduct Form (ATD)

Employees opting for additional benefits or dependent coverage must complete the Authority to Deduct form, allowing bi-monthly salary deductions to cover applicable HMO contributions.

3. Submission to HMO Provider

After verification of ATDs, Customer Care will consolidate and forward all completed forms to IMS for processing.

4. Confirmation of HMO Activation

Once approved and processed, HMO cards or digital credentials will be released to enrolled employees.



AUTHORITY TO DEDUCT GUIDELINES

As provided under *Article 113 of the Labor Code of the Philippines*, salary deductions may only be made:

- With the employee's written consent
- When for the benefit of the employee (e.g., insurance, healthcare)

Therefore, Authority to Deduct form serves as legal consent for Expedise PH to deduct HMO-related charges for voluntary or dependent coverage.

PROMOTION OF SAFETY AND EMERGENCY READINESS

While we encourage the proactive use of this HMO coverage for regular health maintenance, we also emphasize its critical importance during emergency situations. Whether at work or outside, unexpected medical emergencies can arise, and having reliable HMO access ensures swift and proper care.
